Secretary's Report

Treasurer's Report

The Treasurer's Report Summary and Itemized Report were distributed. Dick reported that we have two new members since last month.

As of today's date we have 57 paid members for 2019; 5 paid members for 2020; \$2,836.17 in the general fund and \$2,643.43 in the milfoil treatment program fund. There is a correction in the itemized report expenditures. The 6/27/2019 Milfoil Treatment Program \$385.61 should be divided into: 6/27/2019 Milfoil Treatment Program (Aquacide) \$293.13 and 6/20/2019 Comfort Lakes Association (July 4 Supplies) \$92.48. Lake Treatment Project

The boat has problems making it unusable now, including lack of speed control, carburetor, and steering cables. The boat is being repaired so people with individual permits have been treating themselves. The DNR permit which was granted to the Association to treat 3+ acres of milfoil was apparently based on an old map because it covers an area with water lilies. We assume that next year we will get a permit for 13 acres. We acknowledge that there has been a lot of learning this year but feel well prepared to tackle milfoil early next year. Jeanine would like to see a survey to assess what was accomplished with the treatment.
