- Watercraft Inspections. Weekend and holidays are priorities. CLA \$2,000 CLFLWD \$6,000 County \$5,000 for 660 hours this season.
- Carp fishing. Boats inspected. Education and literature provided at the start of the tournament .
- Water quality. Goals for 2020, 2030 and 2040 established. We had a grade of "B" last year. Rules for new development treat storm water, erosion control, 25' buffer on properties, 50' buffer on wetlands.
- Bixby Park Project. Weirs built to back up water in the wetlands. Mike will be managing the weirs to maintain maximum effectiveness.

- Lilies limit EWM treatment. Limited to a certain # of acres. Permits needed for up to 150' out. Expecting low EWM growth as we have low nitrogen levels.

John Spence. Deep core sampling gives profile of what has come in for past 150 years. We do not have algae levels to support anything but light zebra mussels.
