- There is no <u>DNR grant update</u> as of yet. Jeanine turned in CLA's grant application on February 18. Her impression was that decisions on grants were to be made sometime in March.
- <u>Boat Wake Study</u> –Board members are to listen to the webinar recording prior to the April Board meeting, so we are prepared to brainstorm what our next steps as a Board on this topic should be, including whether to have a special membership meeting on the topic, whether to invite Jeff Maars to speak, whether to accept the recommendations and apply them to Comfort Lake?
- <u>Ice Clean Up</u> we decided that the ice looks pretty clean and a full effort of the association is not needed for this task.
- <u>Boat Launch Clean Up</u> this will be needed and should be scheduled after the ice is out and snow gone, perhaps mid-April. We will plan to discuss it at the next meeting.
