There has been nominal financial activity over the past two months which is typical for midsummer. Only approximately 30% of Big Comfort lake shore households are members which is disappointing. Discussion was continued as to how to get more membership and to learn why people aren't joining. We especially want to reach out to those who have been members in the past. We discussed an online survey vs. in person conversations and felt we would get more honest responses with an on-line survey. Mike M. is in the process of verifying our list of members and their correct email addresses. Regarding Little Comfort, historically we have had a maximum of one family as a member and now we don't have that. Jackie will draft a letter which will be mailed or hand delivered to nonmembers only. The consensus is that we don't believe the increase in dues is the reason for apathy among nonmembers.

Jackie moved to accept the Treasure's Report; Bill seconded. The Treasurer's Report was approved.

Slow-No Wake Restriction

There has been confusion as to when the Slow-No Wake restriction is lifted. This is in part due to the CLFLW's delay in getting the lake levels (it is read approximately every 4 days) and then communicated. For a Slow-No Wake restriction to be lifted the water level has to be .1 below the OHW (887.2) mark for three consecutive days. In approximately 2 weeks, electronic water level monitoring gauges are to be installed which will take the level daily and thus should make much prompter communication as to the slow-no wake status.

Zebra Mussel Collection Plates U of MN

As part of the zebra mussel study an individual from the U was here recently to take underwater pictures of the zebra mussel plates. The plates will be removed around Labor Day.

Final wake boat study – the second phase of the wake boat study has been delayed a year (originally expected in spring 2024) as a new wave flowing downward was seen, which needs to be studied as well. The U reports
